# Wells Branch Community Library District Health Reimbursement Plan 2021

In order to help pay health care expenses, Wells Branch Community Library has set up \$500 Health Care Reimbursement Accounts for each eligible part-time and full-time employee for personal medical expenses. In addition to these monies, every employee and trustee will receive reimbursement up to \$35 per injection or vaccination requested by the Director. These funds may not be renewed in future plan years and will not rollover into future years.

Plan Year: January 1, 2021-December 31, 2021

### Eligibility

All part-time and full-time employees become eligible to access the \$500 upon their one-year anniversary with the Library. However, health care expenses will only be reimbursed for those expenses incurred on or after the employee's one-year anniversary.

# **Qualifying Medical Expenses**

#### **Injection or Vaccination Reimbursement**

From time to time the Director may make a request in writing to employees and trustees to obtain an injection or vaccination. Each employee is eligible to receive reimbursement for the actual cost of the injection or vaccination up to the cost approved in the written request. Unless required by local, state, or federal law injections or vaccinations will never be mandatory.

#### **Reimbursement Process**

Receipts for qualifying medical expenses must be submitted within 45 days of service or purchase to the Library Director in a sealed envelope. Receipts should be submitted on the proper reimbursement form and contain the date of service or purchase. No reimbursements will be given if the employee does not follow this procedure.

#### **Separation of Employment**

Employee access to Health Reimbursement Accounts and Injection or Vaccination Reimbursement terminates upon separation of employment, except that former employees may submit qualifying medical expenses incurred while an employee according to the reimbursement process.
