**NOTICE REGARDING PROHIBITION OF HANDGUNS AT MEETING**

*In accordance with Texas Penal Code 46.03(c), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), is prohibited from carrying a concealed handgun and from openly carrying a handgun in the meeting room(s) during this meeting. Accordingly, the following notice applies to the room(s) where this meeting will be held and is effective during this meeting:*

*Pursuant to Section 30.06 Penal Code (trespass by license holder with a concealed handgun), a person licensed under Subchapter H, Chapter 3411, Government Code (handgun licensing law) may not enter this property with a concealed handgun.*

*Pursuant to Section 30.03, Penal Code (trespass by license holder with an openly carried handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a handgun that is carried openly.*
